Amendment of tax registration forms for taxpayers and the types of tax obligations that constitute the tax vector - D010, D015, and D700

The Order of the President of the National Agency for Fiscal Administration no. 6.580/2024, amending and supplementing the Order of the President of the National Agency for Fiscal Administration no. 1.699/2021, for the approval of the tax registration forms of taxpayers and the types of tax obligations that constitute the tax vector, was published in the Official Gazette no. 1079, on 29 October 2024.

Following recent legislative amendments, the following tax registration forms have been updated:

- **Form 010** - "Declaration of tax registration/Declaration of mentions/Declaration for deregistration".
- **Form 015** - "Declaration of tax registration/Declaration of mentions/Declaration of deregistration for non-resident taxpayers who do not have a permanent establishment in Romania".
- **Form 700** - "Declaration for registration/amendment in the electronic environment of mentions after the tax registration as well as for tax deregistration".

Date of entering into force: 29 October 2024.

Modificarea formularelor de înregistrare fiscală a contribuabililor și a tipurilor de obligații fiscale care formează vectorul fiscal - D010, D015 și D700.

În data de 29 octombrie 2024, în Monitorul Oficial nr. 1079, a fost publicat Ordinul președintelui ANAF nr. 6.580/2024 care vizează modificarea și completarea Ordinului președintelui ANAF nr. 1.699/2021 pentru aprobarea formularelor de înregistrare fiscală a contribuabililor și a tipurilor de obligații fiscale care formează vectorul fiscal.

Ca urmare a unor modificări legislative recente, au fost actualizate următoarele formulare de înregistrare fiscală:

- **Formularul 010** - „Declarația de înregistrare fiscală/Declarație de mențiuni/Declarație de radiere”.
- **Formularul 015**- „Declarație de înregistrare fiscală/Declarație de mențiuni/ Declarație de radiere pentru contribuabilii nerezidenți care nu au sediu permanent în România”.
- **Formularul 700** - „Declarația pentru înregistrarea/modificarea în mediu electronic a mențiunilor ulterioare înregistrării fiscale, precum și pentru radierea înregistrării fiscale”.

Data intrării în vigoare: 29 octombrie 2024.
