The enforcement of certain sanctions under the RO e-Transport system has been suspended until the end of 2025

On 24 April 2025, in the Official Gazette no. 365, Part I, was published the Emergency Ordinance no. 29/2025 on the suspension of the application of sanctions under the Government Emergency Ordinance no. 41/2022 for the establishment of the RO e-Transport national system for monitoring the road transport of goods

- The enforcement of sanctions is suspended until 31 December 2025 for non-compliance with the following obligations: equipping transport vehicles with satellite positioning and transmission devices, transfer of vehicle positioning data, switching on and off the tracking device at the beginning and end of transport.
- The purpose of this measure is to help transport companies adapt their systems to comply with the imposed regulations and to avoid disruptions caused by technical difficulties, as reported by representatives of the business community.

Aplicarea anumitor sancțiuni din sistemul RO e-Transport a fost suspendată până la sfârșitul anului 2025

În data de 24 aprilie 2025, în Monitorul Oficial nr. 365, Partea I, a fost publicată Ordonanța de Urgență nr 29/2025 privind suspendarea aplicării sancțiunilor din OUG nr. 41/2022 pentru instituirea Sistemului național privind monitorizarea transporturilor rutiere de bunuri RO e-Transport

- Se suspendată până la data de 31 decembrie 2025 aplicarea sancțiunilor pentru nerespectarea următoarelor obligații: echiparea vehiculelor de transport cu dispozitive de poziționare și transmisie prin satelit, transferul datelor de poziționare a vehiculului, pornirea și oprirea dispozitivului de localizare la începutul și la finalul transportului.
- Scopul acestei măsuri este de a ajuta companiile de transport să își adapteze sistemele pentru a respecta prevederile impuse și de a evita blocajele cauzate de dificultăți tehnice, semnalate de reprezentanții mediului de afaceri.
