Order of the President of the Romanian Customs Authority approving the Methodological Norms regarding the granting of Authorized Economic Operator (AEO) status.

On January 8, 2026, Order No. 3505/2025 of the President of the Romanian Customs Authority was published in Official Gazette No. 6, approving the Methodological Norms regarding the granting, modification, suspension, revocation, and monitoring of the status of Authorized Economic Operator (AEO).

Main provisions:

- AEO status may be requested by economic operators that meet the criteria established in Article 39 of Regulation (EU) No. 952/2013 (Union Customs Law).
- The request must be submitted exclusively electronically via the EU Customs Traders Portal for AEO (eAEO-STP).
- The Romanian Customs Authority carries out the preliminary analysis, risk assessment, and audit necessary to verify the criteria. Following the audit, an audit report is prepared, forming the basis for approving or rejecting the granting of AEO status.
- The Romanian Customs Authority issues the AEO authorization within 15 days of receiving the audit report.
- Holders of AEO authorizations are subject to ongoing monitoring to verify that they continue to meet the criteria for maintaining the status.

Ordin al președintelui Autorității Vamale Române privind aprobarea Normelor metodologice pentru acordarea statutului de operator economic autorizat (AEO)

În data de 8 ianuarie 2026, a fost publicat în Monitorul Oficial nr. 6 Ordinul președintelui Autorității Vamale Române nr. 3505/2025 prin care se aprobă Normelor metodologice privind acordarea modificarea, suspendarea, revocarea și monitorizarea statutului de operator economic autorizat (AEO).

Principalele prevederi:

- Statutul AEO poate fi solicitat de operatorii economici care îndeplinesc criteriile prevăzute la art. 39 din Regulamentul (UE) nr. 952/2013 (Codul Vamal al Uniunii).
- Cererea se depune exclusiv electronic prin Portalul UE al comercianților vamali pentru AEO (eAEO-STP).
- Autoritatea Vamală Română efectuează analiza preliminară, evaluarea de risc și auditul necesar pentru verificarea criteriilor. În urma auditului se întocmește Raportul de audit, pe baza căruia se aprobă sau se respinge acordarea statutului.
- Autoritatea Vamală Română emite autorizația AEO în termen de 15 zile de la data primirii raportului de audit.
- Titularii autorizațiilor AEO sunt supuși unei monitorizări permanente pentru a verifica menținerea criteriilor de acordare a statutului.
